NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-

1. In order to effectuate the said object of creating and establishing A public Charitable Trust, the Settlor has delivered to and made over to the trustees a sum of Rs.11,000/- (Rupees Eleven thousand only) with intent to part

with the same for forming the basic Corpus of the Trust for investment or investments for the time being representing the Trust and all other properties that may for the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as the "**THE TRUST FUND**") for the Charitable objects and purpose and uses hereinafter expressed with the powers and on the terms and conditions herein contained of and concerning the same.

2. The name of the Trust shall be "**ARVIND MEMORIAL CHARITABLE TRUST**" and the office of the Trust shall be situated at 5/504, Viram Khand, Gomti Nagar, Lucknow - 226080 in the state of Uttar Pradesh, which may be shifted from time to time to such other place or places as the Trustees may deem fit and proper at their discretion.
3. That the Board of Trustees shall be entitled to sue and to be sued in the name of Trust.
4. **OBJECT OF THE TRUST : Aims and Objects of the said Trust emerging out of this deed are :**

- a. To promote education, technical, medical, engineering, management, computer, information technology, legal, social and cultural, amongst the Indian people by establishing, opening, maintaining and running of educational institution, schools, colleges, research institutes including management institutes, computer institute, medical colleges, dental colleges, engineering colleges, etc. for imparting education and training in the concerned disciplines.
- b. Dissemination of knowledge and education in the society for achieving the said objectives, receiving and extending the grants, donations, in cash and kind and assistance in the establishment, maintenance, running, development and extension of schools, colleges, workshops, technical and industrial schools, hostels for the student community, etc.
- c. To establish vocational training colleges/centers for vocational training of youth of the society so as to inculcate in them a high degree of self-reliance.
- d. Establishment, maintenance or acquisition of any existing library for the benefit of the public at large.
- e. To assist the unemployed/educated/uneducated persons for setting up their own cottage industry, business or vocation.

- f. To do any other activity found conducive to generate funds, to be utilized for the purpose as set out hereinabove.

5. **POWERS OF THE TRUSTEES :-**

- a. To accept any donation, Gifts, voluntary contribution, grants or subscription in cash or in kind, from any person(s), body of persons, firms, institutions, Government or trust, with or without conditions, and to collect subscription, donation or aid from State Government, Central Government to augment the Trust fund and use such money for the objects of the Trust.
- b. To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- c. To convert and deal with the property and/or any investments for the time being.
- d. To invest/deposit the Trust Fund in such forms and modes as may be found desirable such as movable or immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other

person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.

- e. To accumulate the income of the trust for eventual application to the Trust objects pending which to invest the accumulation in accordance with the relevant provision of the Income Tax Act, 1961.
- f. To raise or secure payments of moneys and also to lend money either with or without security to pursue the objects of the trust.
- g. To sell, dispose off, alienate or otherwise deal with any property comprising the trust property.
- h. To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent and on such terms and conditions as the Trustees in their discretion may think fit.
- i. To open account in the name of the Trust, Trustees and/or Institutions run/conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- j. To appoint constituted attorneys or agents and to delegate to such attorney or agents all or any of the powers vested on them under

- l. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- m. To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any objects of the Trust.
- n. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions,

- o. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- p. To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be law full for the "Board of Trustees" to made such borrowing on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- q. To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept of money and of aid, donation, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with Government Departments, public and other bodies corporation, companies or

- s. To transfer all or any part of the property, assets, liabilities and engagement of this Trust to any one or more of the trust, societies, institutions of associations with which this Trust is authorized to amalgamate.
- t.
